**Agreement to Translate Overeaters Anonymous Literature**

A license will not be granted unless a copy of this Agreement is signed by an authorized agent of Overeaters Anonymous, Inc.

**Instructions to Complete License**

Paragraph 1. Please enter the current date, month and year, and the name of the service body (region, national/language service board, intergroup) or group (“Licensee”) entering into the License Agreement (if the group doesn’t have a name, please enter the group number).

Paragraph 2. Please enter the name of the Work the Licensee seeks to license for translation. Also enter the language into which the translation will be made.

Provide the signature of an authorized person signing on behalf of the Licensee, the date of signing, and the name of the Licensee. The Licensee’s address, phone and email should be included after the signature line on page 3.

AGREEMENT TO TRANSLATE

1. This Agreement is made the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between Overeaters Anonymous, Inc. (“Licensor”) and \_\_\_\_\_ (“Licensee”), hereinafter the “Parties”.

For good and valuable consideration, the Parties hereby agree:

2. Work. Licensee seeks permission from Licensor to translate an OA publication entitled \_\_\_\_\_, herein known as the “Work,” into \_\_\_\_\_ (*language*).

3. License. Licensor hereby grants to Licensee the non-exclusive right to translate the Work.

5. Ownership. Licensor shall own all rights in the Translation, and Licensee agrees to sign all documents necessary to effect ownership in Licensor.

6. Term. The term of this agreement (“Translation Period”) is for three (3) years from the date of the last signature. A twelve (12) month extension shall be granted upon Licensor’s sole discretion by completing the Exhibit on page 4 and returning it to Licensor.

7. License to Distribute. After the Work has been translated, Licensee agrees to complete License 2: Agreement to Distribute Translated OA Literature for Validation Purposes. Licensee will contact the Licensor to receive the license form, will complete it, and will return it to the WSO before distributing the Translation for validation purposes.

8. Termination. Licensor may terminate this Agreement at any time upon thirty (30) days written notice without cause, or immediately upon breach by Licensee of any clause of this Agreement. Upon termination, Licensee shall turn over all copies of the Translation to Licensor.

9. Law. The Parties to this Agreement understand that this Agreement will be governed and construed under the laws of the State of New Mexico and the United States of America, and the Parties consent to the jurisdiction of the State and Federal Court located in the State of New Mexico USA, and waive any defense to any such jurisdiction.

10. Signature. This Agreement may be executed by a party signing an original and providing a copy of the original to the other party via mail or providing a copy of the original signature via facsimile (fax) transmission. The original or facsimile (faxed) signature of the parties indicated below shall be binding on the Parties.
